TERMS OF USE OWNERSHIP AND OPERATION

Vedicure Wellness Clinics & Hospital (referred to as “we”, us”, “Vedicure”) is the author and publisher of www.vedicure.com and its sub domains (together referred to as “website”) in the internet. AGREEMENT TO BE BOUND BY THESE TERMS OF USE
